Configura is privately owned with over 280 employees worldwide and annual sales of more than \$30 million USD.

Based on technology created by Configura, CET is an intelligent, highly visual and intuitive space-planning software as a service (SaaS) that simplifies specifying and selling of products in a variety of industries. It's a complete solution that quickly and accurately handles every step of the sales and order process. 2. ONBOARDING INVESTMENT

The following items listed below outline the initial investment you should plan for as a Development Partner with Configura. This is the core foundation for success on your first CET project and should be planned appropriately.

2.1. Annual Partner Subscription fee

To remain an officially recognized and published Development Partner on Configura's website the annual partner fee of \$5,000USD must be paid at invoice. The fee includes 3 annual developer licenses of CET Developer bundle or Content Developer bundle, or a mix of the two. Any additional developer license can be purchased at 30% off as long as you retain your certified partner status. The incentive program described below is active as of January 1, 2024. Deals made prior are not eligible for royalty.

Who: Development Partners

Duration: Calendar year, enrollment year prorated per quarter.

Cost in USD: \$5,000

2.2. Benefits

- The annual fee for all Development Partners is \$5K, including 3 free developer licenses, CET Developer or Content Developer (new bundle, CET industries incl. libs, creator, and Spec).
- Announcing an opportunity for our Certified Development Partners to earn royalty on Publishing, Stage and and purchased licenses by same manufacturer.
- 30% discount on all new developer licenses, any Configura Services and events.
- Partners receive 2 free tickets to Excelerate (Partner/Manufacturer Meeting).
- Basic CET training courses is free for Development Partners.
- All self-paced developer training is free for Development Partners, with the first certification attempt being complimentary for all developers that have gone through training.
- All discounts are applied to the current list price.
- No discount on the annual partner fee.

2.3. General setup & responsibilities

- Development Partner is responsible to report any new published manufacturer to Partner Manager at partners@configura.com
- Quarterly business review sessions with your partner Manager
- Maintaining all its developers certified.
- Any conflicting agreements are superseded by the signing of the Partner Agreement.
- The partner agreement is one size fits all, but any other situation not covered under the program will be handled case by case per separate agreement.
- For participation in Partner Program and to be named as a recognized Partner to Configura, signed partner agreement is required.
- Only authorized Partners or customers to Configura will have access to CET Developer. Exceptions may
 occur by authorizations by Partner Managers (expected to be implemented latest 2026 Q1)

2.4. Royalty Payments

2.4.1. Publishing Program

A royalty of 20% will be paid for a onboarding a new manufacturer. Meaning partner is taking a new manufacturer that has no previous developed extensions on to the platform. This includes educating the customer on how the publishing program works and what the cost covers. For royalty to be paid no discount can be offered on the publishing fee which is \$12KUSD in 2025. Royalty will be paid in line with Configura's normal royalty payments and requires Configura to have received payment from customer before royalty is sent to partner and extension published on Marketplace. Payments are electronic and banking information will be requested from the partner to execute payment. The publishing royalty is for first publishing year only, first 4 quarters from account registration and signing in MyConfigura by manufacturer.

2.4.1. Stage

A royalty of 20% of the annual Fixed Fee will be paid for onboarding a manufacturer to Stage (first year only). Onboarding includes educating the customer on how the Stage works and the pricing models. For royalty to be paid no discount can be offered and it's only applicable for manufacturers who are new to Stage.

Royalty will be paid in line with Configura's normal royalty payments and requires Configura to have received payment from customer before royalty is sent to partner. Payments are electronic and banking information will be requested from the partner to execute payment. The publishing royalty is for first year only.

2.4.2. CET License Sales to Extension Owners

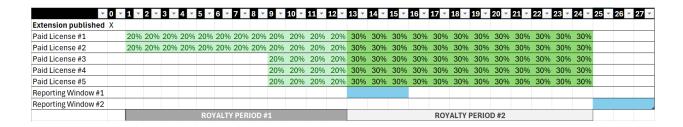
When an extension has been approved for publishing through the extension review process, the partner responsible for developing and launching the customer's extension is entitled to royalties on any licenses purchased by the manufacturer. Licenses acquired within twenty-four months of launch are eligible for royalty, this is measured in two 12-month periods. Licenses bought during the initial period generate 20% of royalty on total recognized revenue for the period. After the second 12-month period renewed licenses generate 30% of royalty on total recognized revenue for that period. Note that all royalty calculation is always based on, without exception, Configura's revenue recognition rule. I.e., only licenses that have been paid and where Configura have received the funds are eligible for royalty.

Example:

- Manufacturer ABC orders 5 licenses in conjunction with their extension launch.
- 12 months later, the manufacturer renews the same 5 licenses.
- The partner will receive 20% of license revenue for the first 12 months and 30% for the renewed licenses, but only if the renewal occurs within the 24-month window counted from extension launch. Note, royalty is calculated on the paid license within the afore-said license period.

Invoicing:

- At the 12-month anniversary of the original availability of the extension, Partner to notify Configura Partner Manager that CET License Royalty is due.
- The partner is responsible for invoicing Configura within 90 days after the recipient of total royalty amount due from Partner Manager.

3.1. Development Partner Program Introduction

This is an overview call between Development Partner Leadership and Key Contacts at Configura. It describes how the Configura ecosystem works and the role Development Partners play. It also covers the types of services Configura offers to supplement and aid in the assistance of your projects.

3.2. CET Introduction Courses

These training courses cover all topics for using the software: navigation, drawing architectural items, placing furniture, rendering, printing, interface with Auto CAD and using SPEC symbols in CET.

Who: All Team Members **Duration**: 10 hours

3.3. Developer & QA Courses

Both Developer training and QA training are highly recommended and certification in mandatory and there to increase quality, performance, safety and there to secure best possible user experience.

Students will learn the basics of the CM programming language and CET extension-focused programming. The course is taught with a "tell-show-do" methodology, and each topic will be presented in lecture, followed by demonstration, and students will then practice new skills through exercises. Students will learn and practice the CM Developer environment and tools, as well as getting practice with some of the core concepts of CM Development: 2D/3D graphics, symbol connections and rules, user interface, and more.

Prerequisites for this course are prior programming experience in any object oriented language (preferably a strictly typed language like C++, C#, or Java) And students should also hold a basic knowledge of CET - "Getting Started with CET" webinar or equivalent.

Who: Developers and Quality Assurance Analysts **Duration**: 30 hours for CET Developer Onboarding

3.4. Basic Certification CET Developer

The Certification are mandatory for all partner developers. Pre-requisites, self-paced Developer Training.

3.5. Self-Paced Catalogue Creator Training

This class covers all the basic information for using Catalogue Creator, Model Lab, and Material Lab, working with existing CAD models, assigning features, materials, style numbers and SIF. We encourage participants to bring their models and data to begin work together on your Catalogues. There is a lot of hands-on and Q&A time built into this class. This workshop training would give you an excellent foundation on which to continue building your Catalogues.
